## **UKG** Benefits - Germany





### Competitive Benefits Fully Paid by UKG

**Eligibility** – All active, regular full-time employees are eligible for benefits on day one of employment.

Medical/Dental/Vision - Occupational health insurance through Allianz includes coverage for costs not refunded by statutory or existing private supplementary health insurance up to 1,250€ annually, including outpatient and dental expenses. UKG subsidizes employees' private or public medical plan 50%.

**Pension** – The pension plan through ERGO includes an employer contribution of 6%. Employees may enroll in a direct insurance plan to contribute additional funds through salary sacrifice up to 4% of salary capped at the social security contribution ceiling.

**Life Insurance** – UKG provides group life insurance coverage, of 2x annual base salary up to a maximum of 500,000€, through Zurich to all employees at no cost.

**AD&D Coverage** – Accidental death and dismemberment (AD&D) coverage is 2x annual salary capped at 250,000€ and 4x annual salary for disability capped at 500,000€.
